Utilization for the CSC Vulnerable Populations/33311 and the County's Special Needs contracts are above target due to program over-enrollment prior to the transfer of operations from BRHPC to the ELC on October 1 <sup>st.</sup> CSC has approved using carry-forward from BRHPC under-utilization from the prior year and the County is reviewing their current utilization to see if additional funds might be available. | New Business:<br>Matching Funds<br>Update          | There was discussion regarding Matching funds from local cities and municipalities. COO Howard Bakalar explained that the application and allocation processes are different for each entity. While Eligibility and Payment operations were still outsourced, some cities had already allocated match funds to BRHPC. Staff is working with each city to have those matching funds re-allocated to the ELC.  |  |
